The Evening's Presentation: Liberia

Marsha Wilcox returned, along with Jon Rossman, to give a presentation detailing her recent activities in Liberia surrounding the establishment of a mission school in a rural area well distant from the country's capital, Monrovia. The school is in Deanville, an area of Gbarnga. Thanks to its recent civil war, Liberia has drawn a short straw. The demographics are telling: about 50% of the population are children and, of those, only one-third are enrolled in school. Money is short. Illiteracy is common. Schools are critical. So is well-judged aid. The school, the Gbarnga Lutheran Training Center, appears to be a successful result of sensitive first-world support of the local administration and staff. Sustainability remains a worry.

The co-presenters, Marsha and Jon, gracefully and lucidly explained the problems found and solutions sought in the founding, building and maintenance of the school. Marsha's photos were informative throughout and wonderfully evocative when appropriate, most especially her portraits of students and staff. The evening was a wonderful expression of the concept of the Human family.
