The Evening's Presentations

September

Nicole Moredcai

Nicole Mordecai, a photographer residing in Weston, MA, gave a pair of short presentations. The first she called *Liquid Life Reflections*. As a newly minted photographer, Nicole found herself fascinated not only by the reflective qualities of water but by the agency of chance in rendering a reflection anywhere from an almost perfect facsimile to something unrecognizable without reference to the reflected object(s), as well. The style of the collection is to invert the image and remove

the original so that only the reflection is shown in upright orientation. Nicole describes the process as, "using water as another lens in my kit." This became a personal project for her. Nicole uses Adobe Lightroom and has decided to allow herself free rein in processing, feeling that this is not reportage, but art.

Nicole's second presentation concerned her exploration of the technique of backlighting. She found strong similarities in the advocacy of backlighting in tutelage she has sought. The desired results, though, can vary greatly. In the same conditions one can take a dark silhouette against a well-exposed background or a well-exposed subject against a blown-out background. In the right conditions, very dramatic rim lighting is also possible. It's not a technique for the faint of heart. Nicole described the practicalities surrounding each of the possible results.

Nicole teaches at LexArt and is heavily involved in the development of the Weston Art and Innovation Center. Her website is https://createwithphotos.smugmug.com

Both presentations, though short, were well organized, dense with information, and intriguing. All in all, a very valuable evening.

October

Member Images - "Shoot the Weeds"

Terri Ackerman showed images of wildlife in the weeds from her recent trip to Malawi. There were elephants, rhinos, a bee-eater, blue waxbills and a water monitor lizard.

Wayne Hall offered images with a more local bent – among others, skunk cabbage, milkweed and pokeweed.

Nicole Mordecai (last month's presenter and new member - Welcome!) had dramatic backlit images shot in Colorado of the likes of goldenrod and grass. This led to an interesting discussion of her post-processing techniques.

Anne Umphrey showed a cosmopolitan group of weeds from, locally, Gowing Swamp and Mattison Field to Sequoia National Park.

Mark Hopkins had images on offer of rockweed on the Maine coast, as well as wild fennel and weeds in early frost.

And lastly, depending on one's definition of "weeds", **Don Sherman's** interesting shots and stories of Mt St. Helens and the Hanford Nuclear site in Washington may or may not have strayed from the theme.
